

Terms and Conditions for Birkenhead Point Brand Outlet

12-month Weekly Fresh Food Giveaway

(August 2018 – June 2019)

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in Gifted ("Promotion") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in NSW local time.
2. Subject to condition 3, this Promotion is only open to NSW residents.
3. The following are ineligible: (i) employees of the Promoter, the Mirvac Group or any of the tenants or retailers in the Participating Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether by birth or adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

6. To receive an entry in this Promotion, eligible individuals must, during the Promotion Period, undertake the following steps:
 1. Spend \$80 across Ground Floor stores (excluding Medical Centre) each week to go into the draw.
 2. Enter your details at the ipad on Ground Floor outside Coles or visit Birkenheadpointwinners.com
 3. Keep your receipts for proof of purchase.

9. Each winner will win \$100 worth of Fresh Food vouchers each week which will include a variety of Fresh Food retailers.

11. Vouchers come in the form of 1, 2 or 3 retailer vouchers equating to \$100.00. Each voucher to be used in one transaction. No change will be given on any remaining balance.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Mirvac Group of companies (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
